हड़तालों की वादी है अब कश्मीर वादी

श्रीनगर। धरती का स्वर्ग कश्मीर अब हड़तालों की वादी बन गया है। साथ ही कश्मीर में सरकारी कर्मियों को छुट्टियों को भी मौजा है। हालत यह है कि लगातार हड़तालों और छुट्टियों के कारण व्यापारी वर्ग अपना व्यापार भी समेटने को तैयार बैठा है।

अगर सरकारी आंकड़ों पर नजर डालें तो 29 सालों के आतंकवाद के दौरान कश्मीर में कम से कम साढ़े 6 सालों तक बंद रहा है। सबसे लम्बा बंद 1991 में रहा था तो उसके बाद अमरनाथ जमीन विवाद पर भी बंद ने रिकार्ड बना डाला था।

इस दौरान हर छोटी बड़ी घटनाओं के विरोध में 29 सालों के भीतर घाटी करीब 2400 दिनों तक बंद रही। कुल 10585 दिनों में 2400 दिन हड़ताल रहने के अलावा साप्ताहिक बाजार बंद अलग से शामिल हैं। इस दौरान सबसे ज्यादा बंद 1991 में रहा। यहां 365 दिनों में 207 दिन घाटी बंद का ऐलान किया गया था। भयाभीत

लोगों ने अलगाववादियों के इन ऐलानों को न केवल माना बल्कि अपने कारोबार को चौपट किया। बंद के दौरान करोड़ों रुपयों का नुकसान कारोबार जगत को उठाना पड़ा। इस वर्ष अगस्त माह समाप्ति तक 100 बार घाटी बंद हुई थी। आए दिन बंद के ऐलान के बाद अब स्थिति में पिछले सालों की तुलना में बदलाव तो जरूर आया पर बंद को ज्यादा तवज्जो नहीं देने वाले व्यापारियों को मजबूरी में पथराव और आमजनी के चलते दुकानें बंद रखनी पड़ती हैं।

घाटी बंद के ऐलान के बाद साप्ताहिक बंदी अलग से होती है। श्रीनगर शहर में रविवार को कारोबार बंद रहता है। इसके चलते 29 सालों के भीतर 1508 दिन रविवार के, कारोबार वैसे ही बंद रहा। आए दिन बंद का ऐलान से यहां के कारोबार में अब तक करोड़ों रुपए का नुकसान हो चुका है। इसके बाद भी व्यापारी बंद के ऐलान पर अपना कारोबार बंद रखने को तैयार रहते हैं। शहर के एक बड़े

शोरूम के मालिक इनायात उल्ला बट कहते हैं कि क्या करे, दुकान में आग लगवाएं। बंद से तंग आ चुके हैं, पर करें तो क्या करें। खोलने की हिमाकत की तो प्रदर्शनकारी क्या कर दें। सोना चांदी आभूषण मार्केट के एक व्यापारी गुलरेज अख्तर करते हैं कि दुकानें मजबूरी में बंद करनी पड़ती हैं। नेताओं का क्या उन्होंने तो फरमान जारी कर दिया। इससे कारोबार पर कितना प्रभाव पड़ता है और कितना नुकसान होता है याह तो दुकानदार ही बता सकता है। इस बंद से किसको क्या मिलता है याह तो वही जाने, पर आम लोगों के लिए मुश्किलें जरूर खड़ी हो जाती हैं।

कश्मीरी सिर्फ बंद से ही परेशान नहीं है बल्कि सरकारी कर्मियों को छुट्टियों के कारण भी उनको परेशानी इसलिए बढ़ जाती है क्योंकि एक जो वैसे ही हड़ताल के कारण जनजीवन रूक जाता है ऊपर से सरकारी कर्मियों को साल में मिलने वाली डेढ़ सौ से अधिक की छुट्टियां उनके लिए मुसीबतें पैदा कर रही हैं।

PSO firing at judge's wife, son re

After four days of investigation into the shootout case of the wife and son of Additional Session's Judge (ASJ) Krishan Kant Sharma, the Special Investigation Team (SIT) blamed instant provocation as the motive behind the incident.

The incident had taken place on Saturday when head constable Mahipal Singh (32), the personal security officer (PSO) of the judge shot his wife Ritu (38) and son Dhruv (18) at the busy Arcadia Market in Sector-49 in Gurugram.

The wife of the judge suc-

cumbed to her injuries on Saturday night, while Dhruv is still critical and under treatment at a private hospital.

Briefing the media on Wednesday morning, the SIT revealed that the incident occurred in the spur of the moment after the judge's wife and son admonished the accused PSO of being untraceable when they returned after shopping.

According to the SIT, the judge's son and wife had gone for some work along with the PSO to Arcadia Market on Saturday. When they returned, the PSO was not present near the vehicle. First, they tried to trace him and then they called

him on his phone.

"When the PSO reached the spot, he was scolded up by the victims for his absence and Dhruv asked him to hand over the key. This irked the PSO and he started beating Dhruv. When judge's wife (Ritu) intervened, the SPO pulled out his service revolver and shot at the mother and son. The accused also beat up the judge's wife before shooting her," said DCP (Crime) Sumit Kuhar, adding that the PSO also tried to destroy the evidence by making an attempt to put injured Dhruv into car but failed and he fled the scene with the car.

The same was Ritu's dying

declaration statement to her husband, ASJ Sharma and another judge at the hospital. Later the Judge wrote the incident in his complaint to police.

The incident had occurred between 3.20 pm and 3.30 pm last Saturday. Videos recorded by bystanders show the accused trying to haul badly injured Dhruv into the white Honda City. Later he was arrested one and a half hours from Gurugram-Faridabad road.

"The whole incident occurred in a span of 10 minutes and after committing the crime the PSO informed the judge about it. He also called up
