करल की वित्तीय हालत पर युडीएफ ने श्वेत पत्र की मांग की

विपक्ष ने राज्य की माकपा नीत एलडीएफ सरकार द्वारा पिछले तीन महीने से वित्तीय संकट का सामना किए जाने पर चर्चा के लिए स्थगन प्रस्ताव लाने की मांग की।

प्रस्ताव पेश करते हुए कांग्रेस के वी. डी. सतीशन ने कहा कि संकट के कारण विकास कार्य रूक गए है और करीब तीन लाख लोगों को सामाजिक

कल्याण पेंशन का बटवारा नहीं हुआ है। केरल के वित्त मंत्री थॉमस इसाक ने कहा कि विकास कार्य नहीं रूके है जैसा कि विपक्ष आरोप लगा रहां है। वह दो फरवरी को राज्य बजट पेश

उन्होंने कहा कि वर्तमान संकट राजस्व और खर्च के बीच के अंतर के कारण है। खर्च बढ़कर जहां 22 फीसदी पहुंच गया है वहीं राजस्व केवल 7.6 फीसदी बढ़ा है। इसाक ने कहा कि जीएसटी लागू होने के बाद राजस्व के बढ़ने की उम्मीद है लेकिन ऐसा नहीं हो सका। उन्होंने कहा कि केंद्र ने हुण लेने पर प्रतिबंध लगा दिया जिससे स्थिति खराब हो गई।
