CEC Zaidi satisfie Goa's poll prepare

MAYABHUSHAN PANAJI

Expressing satisfaction at the level of preparedness for the February 4 Goa Assembly elections, Chief Election Commissioner Nasim Zaidi on Sunday said that the poll malpractices received by his office ranged from abuse of money, misuse of Government schemes for attracting voters and potential misuse of casino for money laundering.

Zaidi, who was on a two-day tour, along with other members of the Commission, to Goa, also said that the country's tiniest State was ideal to test several of the poll-related innovations, especially those on a digital platform. Commission is by and large satisfied with election related activities and prepa-

rations of Goa.

"Commission is committed to maintain purity of elections and to deliver free, fair
and transparent elections. We
have directed the election
machinery to be fearless,
unbiased, neutral and independent from any influence
whatsoever. Conduct and discharge of duties by the election officials would be under
constant watch of the
Commission. Anyone found
wanting on these standards,
Commission will not hesitate
to take stern action," Zaidi told
reporters in Panaji.

Zaidi also said that ever since the notification of the model code of conduct, the Commission had received a wide range of complaints from political parties in the fray. The poll authorities in Goa are using electronically transmitted postal ballot system for 40 constituencies to cover an entire State for the first time under ETPBS. One polling station in each constituencies would all-women team

"Parties expressed apprehension about abuse of money, distribution of gifts and on possible misuse of withdrawal of cash in Casinos. The parties further stated about likelihood of distribution of gifts in last week before the poll," the top poll official

"It was complained that ruling party is using beneficiary data base of Dovernment schemes for threatening, canvassing and coaxing voters to vote in their favour," he further said.

Zaidi also said that various measures were being taken to tackle malpractice and added that law and enforcement agencies both local and central had been readied to crack down on them. "Expenditure monitoring machinery has been fully activated and preventive measures are being taken with coordinated efforts of Income


